- **8.2:** A meeting is being held on 11/05/23 with Laura McClellan, Highways representative to discuss the ongoing issues on the roads surrounding the Brougham area, most notably the B6262. The council discussed the possibility for a Speedwatch scheme and the clerk will make enquiries regarding this
- **8.3:** Weekend road closures in the Eamont Bridge area and around the M6 Lowther Bridge works have caused a great deal of disruption and increased traffic flow, particularly during the War Weekend.
- **8.4:** BPC submitted a response regarding the last consultation of the A66 Trans-Pennine works. No decisions have been announced as yet
- **8.5:** CALC in house training was discussed, with the possibility of inviting neighbouring parishes. The clerk will discuss further with CALC
